Abandoned Children of the Italian Renaissance

Orphan Care in Florence and Bologna

JHU Press Nearly half of the children who lived in the cities of the late Italian Renaissance were under fifteen years of age. Grinding poverty, unstable families, and the death of a parent could make caring for these young children a burden. Many were abandoned, others orphaned.
